Dublin, OH, December 15, 2020 – Effective as of December 15, 2020, CCF Holdings LLC (“CCF”), made an in-kind interest payment on its 10.750% Senior PIK Notes Due 2023 (the “Notes”). The in-kind interest payment was made via a principal increase to the existing global Note in accordance with the indenture governing the Notes. As a result, as of December 15, 2020, the aggregate principal amount of the Notes was increased by \$17,436,910.77 to a total of \$341,844,553.09.
